ii. The term 'force majeure' as employed herein shall mean an event not within the control of either Party which, by the exercise of due diligence, neither Party is able to overcome and this includes any act of God, strike, lockout or other industrial disturbance, wars, insurrections or riots, civil disturbances as well as explosions.

iii. Either Party may terminate this MoU at any time, by notifying the other Party of its intention to terminate this MoU by a notice in writing six (6) months prior to its intention to do so.

iv. The termination shall not affect the implementation of on-going activities/programmes, which have been agreed upon prior to the date of the termination of this MoU
